YACWA Pre-Budget Submission Brief



What is a Pre-Budget Submission?

A Pre-Budget submission is a formal document submitted to the State Government. The document works to highlight the priority areas that Government should be directing funding towards, with a series of 'asks', identifying requests for allocations of money.

Pre-Budget submissions are usually submitted by organisations and Government Departments, relevant to a specific sector. They are submitted through a formal process to The State Government, typically around the end of October to inform the next year's budget.

Where can I find an example?

This is YACWA's inaugural Pre-Budget Submission.

Why is it important?

The Pre-Budget Submission is important because the Government look to these submissions to help inform and allocate funding amounts in the next budget. It is one of the processes they put in place to consult the non-government sectors, as well as departments themselves.

This Pre-Budget Submission is vitally important because there is a state election due early next year, and we believe both parties will be looking to all pre-budget submissions to assist in determining their election platforms.

What will YACWA's Pre Budget Submission look like?

YACWA's Pre-Budget Submission will build on key areas of our work in the past given there is a short timeline involved. It is our intention to pull together a submission that highlights areas that Government should prioritise on behalf of young people and the Youth Sector in Western Australia. The areas we have initially flagged are:

- Strategic Policy and Reform Direction
- Justice
- Housing/Homelessness
- Employment
- Mental Health
- Migrant and Refugee Young People
- Aboriginal and Torres Strait Islander Affairs
- Engaging with Young People

What is the timeline?

Consultation timing will be tight, as the lead in time for this process is limited to 7 weeks. Ideally, we would consult widely with our members over several months in the lead up to completing our submission. Because of this, we will draw on previous work with members and existing knowledge of areas.

The submission is due in by the end of October, meaning all consultation and writing of the formal document will need to have taken place by then.

How can I get involved?

YACWA is keen to consult with its members and the broader community, in order to best inform the submission from people working in the youth sector, young people themselves, or people with direct experience. We will be consulting through the following ways:

- A Member's Survey
- A Consultation Paper
- Workshops and discussions through networks and regular meetings
- Direct feedback from individuals and organisations
- Meetings with relevant stakeholders (where possible)
- Social media engagement
