#### How to vote

YACWA's Board elections follow a proportional voting system-single transferable vote model, where candidates are ranked from highest (1) to lowest (7) in order of preference.

Each eligible voting member will receive an email at their nominated membership contact email with personalised link that directs to the OpaVote voting portal.

#### Who can vote

Each organisational member and individual member (including Life Members, free members 25 or under and fee-paying members) receive a single vote in this election.

If an organisational member representative is also an individual member, they are entitled to cast two votes.

Associate members, non-members and members registering after the commencement of the election are unable to vote.

Voting closes on Thursday 24 November at 11.59pm.

I am a 2017 Churchill Fellow and received the YACWA's Significant Contribution to Youth Work Award 2018. I have been an active member of the YACWA Board and Chair of the Finance Committee for 3 years. I am dedicated to the work of YACWA as our Youth Peak and welcome the opportunity to provide ongoing strategic support and continuity to the Board.

My background is in Education and Youth Work, and I hold qualifications in Management (Community Services). I have experience across Government and Non-Government Sectors within both State and National initiatives. My previous roles have contributed to the WA Education Departments Participation Strategy and the Commonwealth Governments Youth Attainment and Transitions agenda. I moved into the homelessness sector nine years ago as Operations Manager at Indigo Junction. Indigo Junction is a place-based low threshold homelessness provider based in Midland. Today I hold the position of Chief Executive Officer and bring a sound understanding of Youth Work and complex service delivery to the position. I provide oversight to the Indigo Junction Executive Management and support 63 full and part time staff who make up our dedicated multidisciplinary team.

Indigo Junction is a small organisation focused on supporting young people experiencing significant disadvantage. We work in partnership with young people to inform policy, service design and practice and have achieved considerable outcomes with young people who are typically hard to hear, reach and engage. I bring continuity to the YACWA Board through a period of organisational change and growth.

# Please provide a brief bio outlining who you are and any relevant roles, training, education and previous governance or committee experience.

As a young person from regional WA, I am passionate about getting the best for young people and advocating for their needs.

Since October 2021, I have been a member of the Scouts WA Board. This appointment came about after many years volunteering for the organisation, including in several governance roles. I also served 12 months as the Rover Scout representative on their Nominations Committee.

I am dedicated to supporting young people to have the opportunities in life that allow them to be the best version of themselves. This dedication has shaped my involvement with Scouts WA, and my work life. I currently work in disability support, where I assist a number of young people to access education, work opportunities, and their community. While working for the City of Bunbury I was working in their Community Development team and worked closely with the Cities Youth Advisory Council. The Community Development team, along with the Cities YAC, developed programs and events that focused on the needs of young people in the community, especially as a regional city. Many of the issues that we addressed were about accessing services and showing what services were available in the area. Helping young people access services, support, and opportunities is a focus of mine, and is a passion I would bring to the YACWA Board.

As mentioned previously, I have attended the AICD's - Foundation of Directorship course, which provided me with the skills I have needed to be an active member of the Scouts WA Board. I also spent some time on the Scouts WA Governance Review subcommittee, as they started the process of reviewing their organisational Governance structure. ## Please provide a brief bio outlining who you are and any relevant roles, training, education and previous governance or committee experience.

Originally born in Canberra, I moved to Perth on my own to undertake tertiary studies after graduating from college in Egypt. My Pathway to University wasn't as clear-cut as I had initially hoped for and I found myself needing to complete a bridging course by securing a Diploma in Business. I am the first person to graduate from university in my immediate family and managed to do so while living largely self-sufficiently.

Like most students, I slogged it by working extensively across the Hospitality and Retail sector to supplement my studies and support my rent while also juggling other extracurricular commitments. For as long as i can remember, I have always been very passionate about my community's engagement and representation. Throughout the course of my studies, I was twice elected to

serve on the UWA Guild Board of Directors (2019-2021). I worked assiduously to advocate and promote the rights of students. The Board worked cohesively to design broad-based policy which helped deliver real outcomes for students and provide urgent relief during COVID.

In addition to serving on the Guild, I have also been engaged formally with Notfor-Profits like the UN Youth WA Division, Australia-China Youth Association and currently volunteer every Saturday for Swim For Refugees and occasionally with my Local Surf Life Saving Club.

## From everything you know about being on a board, YACWA and the youth sector, how would you make a contribution to the Board?

My overriding goal is to work constructively with the current Board to ensure YACWA is able to reaffirm and consolidate its position as the principal advocate for Young people living in Western Australia.

I am hoping to resume my master's in public policy, and I am naturally interested in leveraging my skills in this area to help evaluate, scrutinize Policy in this space, as well as prosecuting new ideas that into the mainstream debate.

The Board can play an important role in shaping and guiding the strategic direction of the organization in a way which ensures it operates consistent with the ongoing and emerging problems young people face. I am especially keen to see inroads being made in tackling housing and food insecurity, advancing services to people from culturally and linguistically diverse communities, challenging Toxic Masculinity, and greater advocacy for International Students facing exploitation in the workplace.

I suppose the board should strive to balance these needs in a way which is proportionate to their outcomes. Governance provides the critical regulatory infrastructure that will ensure YACWA remains liquid, sustainable and risk averse. So, in practice, all of these challenges are inextricably linked

I did sit on the Strategic Resources and Risk Commitee during my tenure at UWA Guild. We canvassed new reforms that provided better oversight into the organizations management and engagement with external parties.

During these periods I also played a leading role in introducing new welfare policies, namely the Graduation Gown Assistance Program which eliminated the cost of gown hire for students from Low SES background or those experiencing unforeseen financial emergencies. We were able to convince the supplier to participate in the program, thus nullifying the cost to the Guild.

### SHANNEN VALLESI

# Please provide a brief bio outlining who you are and any relevant roles, training, education and previous governance or committee experience.

I am a Research Associate and PhD candidate at the Institute for Health Research, University of Notre Dame. My PhD explores the impact of chronic homelessness on health needs, outcomes, and access to care. I am passionate about research that has real world impact, thus the voices of people experiencing homelessness are embedded within my research from the outset. I led the 50 Lives 50 Homes Housing First program evaluation, collaborating with YACWA and other youth services to determine critical differences and recommendations for young people experiencing/at risk of homelessness; this built off YACWA's Youth Homelessness Action Plan. My role involves extensive governance, budgeting and reporting responsibilities to multiple different organisations and government bodies.

I am the Terms and Policy Officer on the Students and Young Professionals in Public Health Committee (PHAA) and have previously served on multiple University of Western Australia committees (including student, alumni and health and safety committees).

### From everything you know about being on a board, YACWA and the youth sector, how would you make a contribution to the Board?

I am a passionate advocate for reducing barriers to service and support access for marginalised groups. Underpinning my robust evidence-base and knowledge of key issues facing young people (across homelessness, health, and community sectors) is a solutions-driven focus. My work cannot have impact without aligning to the sector and end-user needs.

My vast knowledge of Housing First principles, evaluations, and fidelity complements YACWA's commitment to the development of a Youth Housing First Framework. I have experience of managing multiple large, national projects (including budget and reporting compliance, risk management, conflict resolution), writing policy submissions, and working with different levels of government to implement change.

While I have not had the opportunity to serve on a Board yet, I have served on 7 different committees including 3 as a student/young person representative. Additionally, I will apply for the Emerging Leaders in Governance Program (opening tomorrow) to increase my capacity in Board leadership.

# YACWA has two sub-committees that support risk, finance, governance and organisational sustainability. Please provide examples of your knowledge and/or experience of these governance challenges.

Academia is a traditionally very insecure workplace, as someone who has been on "soft-funding" throughout their entire career and who manages a team of 7 staff on this type of funding, I know the importance of ensuring proper governance and risk management processes are in place. At any given time, my team is involved in around 15-25 different consultancy/research projects. Each of these projects have specific reporting requirements, timeframes, stakeholders to liaise with, budgets to comply with, often have governance/steering committees to report to and differing contractual obligations to be met. Additionally, working for a large national organisation there are multiple governance and policy processes that need to be complied with.

As such, part of my role is to ensure the sustainability of the team which includes monitoring budgets, project deliverables and exploring additional funding opportunities (including applying for large competitive grants, or engaging in research consultancies with community organisations).

# Please provide a brief bio outlining who you are and any relevant roles, training, education and previous governance or committee experience.

My career has been built on working to improve the lives of children and young people, and giving them a voice in the decisions and systems affecting their lives. This has included direct service delivery and case practice in local council and child protection, and over the past 10 years, working in advocacy pushing for change in our legal, service and support systems to improve child and youth outcomes - as Manager of Policy with the Commissioner for Children and Young People, and State Coordinator with CREATE Foundation.

I have a Bachelor's Degree in Psychology, am an alumni of Leadership WA, have served on the YACWA Board for 6 years, and was previously a Board member of the Child and Family Youth Agency Alliance (CYFAA), Committee member for the Alliance for Children at Risk, and a member of the Ministerial Advisory Council of Child Protection.
